1 that were possible remakes for the provisionals,  
2 because of all the different right church, wrong pew,  
3 wrong location, not given a 12-D form, 17-year-old  
4 voters, and no style written on the affirmation form,  
5 501 of the 589 ended up having to be remade. The  
6 other 88 were the correct ballot style. So that was  
7 for the provisionals, and then also the provisionals  
8 as far as remakes because the ballot was damaged or  
9 we couldn't run them, there was 21 of those.

10 DIRECTOR ANTHONY: Okay. And we don't  
11 need to do anything with that; correct?

12 MR. MANIFOLD: Correct. I just wanted  
13 to give you the guys the final numbers.

14 MEMBER MARINELLO: Thanks, Zach.

15 DIRECTOR ANTHONY: And we have the  
16 provisional ballot update, Renee Klco.

17 MS. KLCO: In front of you you should  
18 have the newest and final. The only difference, we  
19 moved the ones that you approved or rejected into the  
20 correct categories, and last night we found one good  
21 one that was in the rejected, so we went ahead and  
22 processed it with Jeff and put it -- moved it from  
23 the rejected to the accepted, and our figures balance  
24 with Jeff's figures. My figures balanced and are  
25 ready to go with the Secretary of State.

1 DIRECTOR ANTHONY: Great. Thanks.

2 MEMBER SINNOTT: Let us remember for  
3 future postelection meetings the motion remained  
4 yesterday to authorize the remaking of the ballots.  
5 We'll incorporate that for future agendas.

6 DIRECTOR ANTHONY: All right. We'll  
7 move on to the certification of the March 15th  
8 Primary Election results.

9 Is that you, Mr. Mackey?

10 MR. MACKEY: That's me. You have in  
11 front of you the final official report there. Out of  
12 799,673 registered voters, 328,379 voted, for a  
13 turnout rate of 41.06 percent.

14 DIRECTOR ANTHONY: Wow, that's not good.

15 MEMBER MARINELLO: Yeah.

16 MR. MACKEY: We have no races within the  
17 threshold for automatic recount. I do have the  
18 certification form for you to sign here, let you  
19 peruse that (indicating). Also attached there is the  
20 official Write-In Canvass, so the Write-In Canvass is  
21 also there.

22 DEPUTY DIRECTOR PAYNE: Jeff, there  
23 weren't any races within the threshold of --

24 MR. MACKEY: Automatic recount.

25 DEPUTY DIRECTOR PAYNE: Automatic

1 recount, but were there any changes in any races that  
2 moved from election night to --

3 MR. MACKEY: One of the ones that we  
4 were looking at was the Paula Brooks --

5 DEPUTY DIRECTOR PAYNE: Central  
6 Committee.

7 MR. MACKEY: -- Central Committee race  
8 in Upper Arlington, 6, which did change the results  
9 from the -- unofficial, on Page 13, the third race  
10 down. Paula Brooks was behind by one, and she is now  
11 winning by four.

12 MEMBER SINNOTT: It's now 308 to 304.

13 MR. MACKEY: Correct.

14 MEMBER SINNOTT: All right.

15 DIRECTOR ANTHONY: So that was the only  
16 one we had; right? What about the one for that guy  
17 that was --

18 DEPUTY DIRECTOR PAYNE: Lockhart and  
19 Ricketts.

20 DIRECTOR ANTHONY: Yes.

21 MR. MACKEY: Republican Central  
22 Committee Ward 9, that was within one vote and it  
23 remained within one vote. They each got two  
24 provisional ballots cast for them, so --

25 DIRECTOR ANTHONY: Okay. Great.

1           MEMBER HAAS: I move the Board certify  
2 and declare as final the official canvass of votes  
3 cast at the March 15th, 2016, Primary Election as  
4 submitted by the staff.

5           DIRECTOR ANTHONY: Is there a second?

6           MEMBER MARINELLO: Second.

7           DIRECTOR ANTHONY: All those in favor?

8           (Vote taken.)

9           DIRECTOR ANTHONY: That motion carries.

10           Now we have to do a postelection audit.  
11 Is that again you, Mr. Mackey?

12           MR. MACKEY: A postelection audit must  
13 be conducted in even year general elections and  
14 presidential primary elections. To conduct the audit  
15 we have to choose -- well, first, you guys have to  
16 choose -- we're going to do it by voting location  
17 because our machines are not based on precinct.  
18 They're based on voting location, and once that has  
19 happened, we have to choose the lids that we are  
20 going to audit, the voting locations up to and  
21 including five percent of the total vote cast at the  
22 election.

23           MEMBER SINNOTT: It sounds like a couple  
24 of motions are in order, then, so I move that the  
25 Board set the postelection audit to begin April 11,

1 2016, until completed and that the audit be conducted  
2 in accordance with Secretary of State's Directive  
3 2012-56 and be held at the Franklin County Board of  
4 Elections, 1700 Morse Road.

5 DIRECTOR ANTHONY: Is there a second?

6 MEMBER HAAS: Second.

7 DIRECTOR ANTHONY: All those in favor?

8 (Vote taken.)

9 DIRECTOR ANTHONY: That motion carries.

10 MEMBER MARINELLO: Voting location now.

11 I move that the Board conduct the postelection audit  
12 by voting locations, using the Location  
13 Identification Number for each of our 389 voting  
14 locations.

15 MEMBER SINNOTT: Second.

16 DIRECTOR ANTHONY: All those in favor?

17 (Vote taken.)

18 DIRECTOR ANTHONY: Motion carries.

19 MR. MACKEY: I'll choose the voting  
20 locations by lot or by roll of the dice here, I  
21 guess, technically. You have in front of you the cup  
22 with the dice in it, if you'd like to use the cup as  
23 the roller. I laid before you there the instructions  
24 on how to read a four-sided die. We're going to go  
25 with a four-sided die this time to --

1 MEMBER MARINELLO: Okay.

2 MR. MACKEY: It will be the number that  
3 is right side up along the bottom of the four-sided  
4 die, and it will be the same on all three sides.

5 MEMBER MARINELLO: How about if I roll  
6 them and you read them?

7 MEMBER SINNOTT: Why a four-sided die,  
8 Jeff?

9 MR. MACKEY: It's a gaming dice at the  
10 hobby shop.

11 MEMBER SINNOTT: All right.

12 MEMBER MARINELLO: Do I roll them all?

13 MEMBER SINNOTT: That's right. You're  
14 our roller.

15 MR. MACKEY: I have a system here to  
16 tell us --

17 MEMBER MARINELLO: (Rolls dice.) Good  
18 luck. It's hard.

19 MEMBER HAAS: Well, the red one is four,  
20 and the blue one is zero, and how do you do the --

21 MR. MACKEY: That looks like a two along  
22 the bottom there. It's the number that's right side  
23 up along the bottom.

24 MEMBER HAAS: Two.

25 MR. MACKEY: So two, four, zero, is that

1 what you said?

2 MEMBER HAAS: Two, four, zero, yep.

3 DEPUTY DIRECTOR PAYNE: So we want the  
4 green, then the red and blue?

5 MR. MACKEY: Then the red and then the  
6 blue.

7 DEPUTY DIRECTOR PAYNE: Okay. Green,  
8 red, blue.

9 DIRECTOR ANTHONY: Do you need another  
10 one?

11 MR. MACKEY: Yes.

12 DIRECTOR ANTHONY: Roll again.

13 MR. MACKEY: We'll do this a couple of  
14 times.

15 MEMBER MARINELLO: (Rolls dice.)

16 MEMBER HAAS: Okay. Green is two, red  
17 is zero, and blue is four.

18 MEMBER MARINELLO: (Rolls dice.)

19 MEMBER HAAS: Green is four. Blue is  
20 five. Red is four.

21 MEMBER MARINELLO: (Rolls dice.)

22 MEMBER HAAS: Three, blue is seven, and  
23 red is six.

24 DEPUTY DIRECTOR PAYNE: We're trying to  
25 get red as second; right?

MEMBER HAAS: Three, six, seven.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Two, three, five.

MEMBER HAAS: Two, five, seven.

MEMBER SINNOTT: Don't be shy in calling  
bingo if you have it.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Three, seven, four.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Four, eight, six.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Three, four, one.

MEMBER MARINELLO: (Rolls dice.)

DEPUTY DIRECTOR PAYNE: This will tell  
you when you reach five percent; correct?

MR. MACKEY: (Nods head.)

MEMBER HAAS: Four, six, two.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Four, six, one.

MEMBER MARINELLO: (Rolls dice.)

MEMBER HAAS: Four, eight, zero.

1 MEMBER MARINELLO: (Rolls dice.)

2 MEMBER HAAS: One, eight, nine.

3 MEMBER MARINELLO: (Rolls dice.)

4 MEMBER HAAS: Two, nine, seven.

5 MEMBER MARINELLO: (Rolls dice.)

6 MEMBER HAAS: One, six, nine -- one,  
7 nine, nine. Excuse me.

8 MEMBER MARINELLO: (Rolls dice.)

9 MEMBER HAAS: One, four, eight.

10 MR. MACKEY: Close.

11 MEMBER MARINELLO: (Rolls dice.)

12 MEMBER HAAS: Three, five, nine.

13 MR. MACKEY: I got it. Thank you very  
14 much.

15 MEMBER SINNOTT: Very good.

16 DIRECTOR ANTHONY: You will receive a  
17 check in the mail.

18 All right. So what happens now, Jeff?

19 MR. MACKEY: Now we will set up the  
20 paper ballot standards to kick out the ones in these  
21 lids, and we'll also pull the voter verified paper  
22 audit trail rolls of paper from the voting machines,  
23 and starting on Monday we will begin the hand canvass  
24 of those items. Once we get to the end, if there are  
25 any changes, we will let you know if we'll have to

1 recertify for any changes. I would expect them.  
2 Generally they are very small, as long as we're not  
3 over some threshold of half a percent or something  
4 like that, we won't have to expand our audit.

5 DIRECTOR ANTHONY: So the countywide,  
6 how is the countywide audit? Are these the same  
7 numbers for that as well?

8 MR. MACKEY: Yes. We'll use the same  
9 locations for all three items, the presidential,  
10 Democratic presidential delegates, the Supreme Court  
11 seat, Democrat, and then the county treasurer race.

12 DEPUTY DIRECTOR PAYNE: So they do not  
13 have to pick one of the races, the Board?

14 MR. MACKEY: Yes. I'm sorry. Yes.

15 MEMBER SINNOTT: So the Board should  
16 give instruction about which countywide race to  
17 audit.

18 MR. MACKEY: Yes.

19 MEMBER HAAS: I'll just throw out a  
20 random, the county treasurer's race.

21 MEMBER SINNOTT: Of the contested races  
22 that might be audited, that is actually the closest  
23 one, so I think it's a fine suggestion.

24 Is that a motion, Mr. Haas?

25 MEMBER HAAS: Yeah. I'll move that we

1 audit the county treasurer's race.

2 DIRECTOR ANTHONY: Is there a second?

3 MEMBER MARINELLO: Second.

4 DIRECTOR ANTHONY: All those in favor?

5 (Vote taken.)

6 DIRECTOR ANTHONY: Motion carries.

7 MEMBER SINNOTT: I don't think there's  
8 any more business to come before the Board.

9 DIRECTOR ANTHONY: There is no more  
10 before the Board. Is there a motion to adjourn?

11 MEMBER MARINELLO: So moved.

12 DIRECTOR ANTHONY: Is there a second?

13 MEMBER HAAS: Second.

14 DIRECTOR ANTHONY: All those in favor?

15 (Vote taken; motion passes.)

16 DIRECTOR ANTHONY: We stand adjourned.

17 (Thereupon, the meeting adjourned at  
18 11:30 a.m.)
